PROJECTS

The Electrician will be out doing some work in the courtyards behind the units. There are multiple areas on the property where the ground lights haven't worked since the storm. These lights point upward toward the trees and other landscaping.

EXTERIOR MAINTENANCE

Per Article VII of our documents the owner is responsible for exterior maintenance which includes doors, fences, windows, gutters & lanais including lanai windows. We have noticed that there are several fences that need repairs. There is some lanais that need door and window repairs. Lately we have had several units that have wood rot around windows causing interior leaks. Again wood repair is owners responsibility.



Some units have branches and weeds growing out of the gutters. This causes damage to the roof itself. If you need someone to clean them out please contact the office.



WATER HEATERS



The office had a water heater leak recently which caused a major remodel issue. Keep an eye on the installation date of water heater. They only last about 8-10 years. You definitely want to avoid a costly damage claim.

INSURANCE CLAIM

I have furnished the insurance adjuster all information and the certificate of completion from the contractor.

Our insurance renews on April 7th—by closing out claim it will help us get insurance hopefully without too much increase.


